# THE SECRETARY OF EXPULSION

OFFICIAL SECRETARY POWER ORDINANCE



This document is an official Ordinance issued by the Department of Secretaries and grants and defines all Secretary Powers and Secretarial Duties held by THE SECRETARY OF EXPULSION, SHOGRAZ DOG.

These Secretary Powers are considered in-effect and granted upon receipt of this Ordinance by the Secretary above named and are in effect until receipt of an ordinance with a date more recent than April 2, O'J Ungle or until OFFICIAL notification from the Secretary of Secretaries that you have been removed from the Office of Secretary of Expulsion or until the start of a Trial in which you are involved. *(Powers are restored automatically after the trials end.)*

These powers persist through an Official Name change.

These powers may be subject to Addendums by the Department of Rules.

The above named is removed from any existing Offices of power and stripped of any previously held Secretary positions.

This ordinance will be recorded and made available in document form to the entire dog club.

**The Secretary of Expulsion** holds the axe of reparation. He is the conductor of consequences, an executioner of exiles, the end of hype.

The following pages list THE OFFICIAL POWERS and SECRETARIAL DUTIES held by this position.

To be able to wield your Secretary powers you are expected to perform ALL of the DUTIES listed within this ordinance and will be held accountable by the Secretary of Secretaries for any ghettoing out of these duties.

# **POWERS IN DEPTH**

## **YOU HAVE THE POWER TO:**

*Expel a sitch from the Dog Club.*

You have the power to expel a sitch from the Dog Club. The sitch you are expelling does not need to be inducted to be Expelled. You may expel Hooples, Official Friends, Nugs, Dogs, Secretaries and specific animals. This does not include inanimate objects and you cannot expel groups of sitches. (*I.e. all Ghetto Girls or all Raccoons.*)

A Secretary cannot be Expelled from The Dog Club without a Trial. A Secretary Expulsion trial verdict must have at least two Secretarial seals of approval, i.e.: signatures, in addition to the Secretary of Judgment. However, a Secretary Expulsion trial verdict *against* the Secretary of Judgment does not require the Secretary of Judgment; instead, this trial requires merely two Secretarial seals of approval.

Once you have decided to Expel someone, you must interface with the Maester of Ceremonies to set an Expulsion date and plan the Expulsion ceremony. The two of you will work hand in hand in planning the expulsion as they will officiate in the ceremony.

## **YOU HAVE THE POWER TO:**

*Exile a sitch from the Dog Club.*

You have the power to Exile a Member of the Club to banishment. They must be banished to a specific place (i.e. Wow, the Mall, Game Haus.) And are only allowed to hoop it with the Club at that specific place until their exile ends.

As a default unless otherwise stated in the Banishment Decree, exiled dogs can always hoop it up on the DCF and Slack (*or the equiv.*)

Banishment Decrees should always state a date when the exile will end. And exiles cannot be set longer than 2 years.

Each week, any number of Dogs can submit Exile Reprieves to the Department of Induction. Each reprieve received will automatically reduce the exile term by 1 week.

You cannot exile a dog during a season in which he has been unbanished.

# POWERS IN DEPTH cont.

## **YOU HAVE THE POWER TO:**

### *Expire Phases.*

You have the power to set an expiration date of a current phase or to immediately expire it, phasing it out officially. *(Phases are defined in this ordinance as games, activities, hobbies, food, drinks or places that the Dog Club has at one time phased into engaging in with some amount of regularity.)*

You cannot expire a phase that has been phased in for less than 1 month.

You cannot expire Official Sitches of the Dog Club *(drink, etc.)* that have been phased in for less than 1 year.

You cannot expire phasefests or fests of any other kind.

## **YOU HAVE THE POWER TO:**

### *Expedite delayed Secretary Powers.*

Some secretary powers are delayed before going into effect, such as a Secretarial Discontinuance or a prolonged Induction date. You may expedite any power that has already been issued from another Secretary that is awaiting a future date of fruition.

- **Any Power affected by 'Stack Delay'**
  - *(Delayed by Department of Rules: Club Rule 5)*
- **Discontinuance**
  - *(Delayed by Department of Secretaries Ordinance)*
- **Induction & Secretary Appointment**
  - *(Scheduled by Secretaries of Induction and Secretaries, respectively)*
- **Trials**
  - *(Scheduled by Secretary of Judgment)*
- **Any Power self-delayed by their own Department**
  - *(Example: Department of Judgment announces an Official Vote will take place on March 3)*

You cannot expedite delayed powers issued from your own Department.

# **POWERS IN DEPTH cont.**

## **YOU HAVE THE POWER TO:**

*Expunge Dog Club Records.*

You may expunge any public Dog Club record that you wish to remove from the public register. All records expunged by the Department of Expulsion will be sealed and moved out of Public Access to their own category ('SEALED FILES') in LEVEL 4 club archives.

## **YOU HAVE THE POWER TO:**

*Extinguish Dog Club Rules.*

If a rule is created by the Department of Rules that you find to be dangerously compromising, unbalanced, biased or detrimental to the club itself. As Secretary of Expulsion, you reserve the right to Extinguish any rule that fits this criteria.

If a rule is extinguished, the Secretary of Rules cannot create a similar or alternative version of that rule until the next Dog Club season.

If the Secretary of Expulsion extinguishes a rule as an exploit or means to gain personal advantage, a trial should be immediately held.

## **YOU HAVE THE POWER TO:**

*Excuse and Deny Official Dog Club Badge S. Attempts.*

Using the guidelines set forth by the Department of Rules in the Badge S. Guide, you have the power to excuse and deny Badge S. attempts as you see fit upon seeing an official Badge S. post on the DCF. By denying the badge, the Department of Expulsion is disallowing the Badge attempt to be approved by the Department of Judgment in the future.

The Department of Judgment reserves the right to respond to a Badge S. denial within 48 hours of issuance. If Judgment responds to the Badge S. denial with approval of the same Badge S. within 48 hours, the Badge S. goes to trial. If Judgment fails to respond to the denial within 48 hours, the denial of the badge stands. The badge will not be awarded on that attempt.

# **POWERS IN DEPTH cont.**

## **YOU HAVE THE POWER TO:**

*Execute Dog Club Wills.*

Any dog may file his Official Dog Club will with the Department of Expulsion. This will can include last wishes and possessions that the dog wishes to leave to other members of the club in the event of Death or Expulsion.

In the event of a Dog's death, the Secretary of Expulsion will become Executor of the most recent Dog Club Will that dog had filed with the department. It is the secretary's duty to execute the will to best of his abilities and powers.

In the event of a xog's expulsion, the Secretary of Expulsion will become Executioner of the most recent Dog Club Will that the XAWGG had filed with the department before meeting his just deserts. It is the secretary's duty to ensure that as little of the xog's wishes and desires come true. If executing their wishes will lead to a Victory of the Dog Club, then you may use your best discretion in your duties on this front. *(No reverse psychology xog traps will fly here.)*

All Dog Club Wills should upon completion be submitted to the Department of Judgment for Document Judgment. And that judgment when finished should be presented to the Department of Expulsion as well as the Testator, who will have an opportunity to revise their will if their judgment inspires them to do so.

## **YOU HAVE THE POWER TO:**

*Expend a strike.*

A strike is an OFFICIAL DOG CLUB measurement of lodgeness. And should only be given to someone you deem to be completely LODGING it and who needs a decent dose of ponita from THE SECRETARY OF EXPULSION.

A trial should be called once any dog receives their third strike (or Dog forbid *each* third strike.)

# **SECRETARIAL DUTIES**

It is your duty to:

## **INFORM THE DEPARTMENT OF SECRETARIES WHEN ANY POWER IS USED.**

You will not always want to ANNOUNCE publicly when you have used a power, but you must always inform the Secretary of Secretaries or his department afterwards.

Failure to do so will invalidate the power.

Informing the Department of Secretaries can be done casually in conversation, officially in email or letter, through their actual Department or in any public capacity.

All PUBLIC DOG CLUB Announcements will count in this regard and you will not need to inform the Secretary of Secretaries in addition to the announcement.

It is your duty to:

## **ESTIMATE AND MITIGATE POTENTIAL EXPULSION DAMAGE TO THE CLUB**

Expelling sitches is never clean. And often times taking the wrong Jenga block out of the tower can result in an avalanche. It is your duty as Secretary of Expulsion, to gauge the risks of each expulsion and weigh the potential consequences of damage to the Dog Club as a whole.

Once the damage potential has been gauged, it is your duty to leverage the club and its members into as favorable a position as you can, in preparation for the expulsion.

If the damage assessment seems too high, it is your responsibility to explore alternatives and weigh these against the atrocities that the (assumed lodge) sitch that you are considering expulsion has committed.



# **SECRETARIAL DUTIES cont.**

It is your duty to:

## **HAVE A LIL CHAT WITH STRIKE RECIPIENTS**

Nothing too hardcore, they are most likely ponita'd to the max already. But a few weeks after the incident, you should set up a lil chat with them.

It is your duty to:

## **CREATE & MAINTAIN AN OFFICIAL LIST OF ENEMIES OF THE DOG CLUB**

The Official list should contain every current Dog Club Enemy, their Name, expulsion date and record the incident they were last seen. It is your responsibility to create the format, keep it up to date and ensure it is publicly available.

It is your duty to:

## **CLARIFY WHAT YOU CONSIDER EXPELLABLE OFFENSES**

Even the threat of expulsion should not come as a surprise to sitches, as it should only result from an action or series of action that has been clearly defined as actionable offenses (See Rules Dept.) If there are other areas not covered by the Rules of the club that may get a Dog into hot water with your department, it is your duty to clearly illustrate these areas beforehand.

It is your duty to:

## **EXECUTE DOG CLUB WILLS TO THE BEST OF YOUR ABILITY**

This is pretty much covered very well above in 'Power in Depth' but it is one of your most solemn duties and bears repeating. Part of taking this appointment is an oath to attempt to ledge up a Dog's Will and last wishes.

*(as long as it doesn't break or lead you to break any Dog Club rules.)*

# **SECRETARIAL DUTIES cont.**

It is your duty to:

## **MANAGE THE PONITA BOX**

The ponita box resides in the Department of Expulsion and as Secretary, you are ultimately responsible that the contents of the box do not become revealed prematurely. It is your duty to make sure sitches have access to add ponita to the box. If no ponita is being added, you may want to set up prompted times and give dogs access to pen and paper to ensure that some ponita is added each year.

As long as it doesn't conflict with any other rules, you are in charge of the box and picking the time to reveal any ponita. This is a duty, not a power.

It is your duty to:

## **AVOID PHASING OUT THINGS PREMATURELY**

Similarly, to gauging the damage an expulsion might cause, your department should actively seek to not officially phase out phases before their time. This does not mean to completely avoid ruffling feathers, as every phase has a select few that cling to their dying breath.

But NF try to be ledge and don't fuck up the phase hoop.

It is your duty to:

## **INFORM DOGS OF EXILEMENT**

You may use Dog Club Rep as proxy.

It is your duty to:

## **MAINTAIN 'THE SEALED FILES'**

Each time a record is expunged, you must ensure it is added to The Sealed Files.

# **SECRETARIAL DUTIES cont.**

It is your duty to:

## **CREATE & MAINTAIN A LIST OF COOLDOWNS OF THE DOG CLUB**

The official Cooldown List should contain any sitch that the entire Dog Club should officially “cooldown” from until a predetermined (and specified) later date. The list should also include the date of beginning and ending the cooldown, including possibly a record of the last time the sitch was hooped. It is your responsibility to define a “cool down,” create the format, keep it up to date and ensure it is publicly available.

Do not take lightly what goes on the Cooldown List as some dogs may consider it ponita for sitches to hoop a sitch while it is actively on the Cooldown List.

It is your duty to:

## **HOLD COOLDOWN ANONYMOUS SYMPOSIUMS**

The official Cooldown List’s purpose is to cooldown any particular sitch that the Dog Club has hooped up redondolously in the recent past. For some, cooldowns will be fairly easy; for others, cooldowns will be N’FUCKIN’ hard to NF bare. The Department of Expulsion, thus, must develop a system of offering and hosting “Cooldown Anonymous” Symposiums. These Symposiums will allow afflicted Dogs to air their grievances in regard to a Cooldown that they dearly miss hooping.

The Cooldown Anonymous Symposiums may be held *physically* or *digitally* (i.e. on Slack or the DCF) at the request of the Anonymous Dogs who wish to complain about their buyge on Cooldown. The Department of Expulsion is in charge of hosting the symposium, listening to grievances, and empathizing with sitches.

It is your duty to:

## **ATTEND DOGMASS**

The truest marker of activity. ALL secretaries *must* attend Dogmass or risk Discontinuance.

# **SECRETARIAL DUTIES cont.**

It is your duty to:

**SUBMIT**

## **AN ANNUAL SECRETARY REPORT**

to THE DEPARTMENT OF SECRETARIES and THE DEPARTMENT OF JUDGMENT on the BLAST AUS (JAN 19) of **EVERY YEAR.**

The REPORT MUST INCLUDE the following **5 SITCHES** and can be as long as the Secretary is buyin (Keep in mind this goes to Judgment for Document Judgment.)

### **SECRETARY REPORT SITCH 1: THE YEAR IN REVIEW**

This segment outlines every sitch you did during the past year in your official office as Secretary. If you used your powers, go into depth outlining the circumstances that surrounded the event and the your thought process of the time of making it.

### **SECRETARY REPORT SITCH 2: AT LEAST ONE DIAGRAM**

Every Secretary report must include at least one CHART or diagram that displays some hoop info graphic in relation to your report. This can be a pie-chart, a Venn diagram, a classic GRID type sitch or another type of sitch of your choosing. THIS diagram should not take up a full PAGE if your report is being submitted as the GHETTO minimum of 3 pages. But may take up a full page if your report is MORE than 4 pages. ALSO, do not limit yourself to just one diagram or illustrative example. IF your report is longer than 3 pages you should be able to include as many illustrative aids as you wish.

### **SECRETARY REPORT SITCH 3: SECRETARIAL REFORM**

If you think your powers are unbalanced or not powerful enough to enact a effective display of your responsibilities, this is the section to present your case to the DEPT. OF SECRETARIES. How would you personally improve your POSITION? You may address things like POWERS, DUTIES, process of APPOINTMENT, or official INTERACTION with other SECRETARIES. In this segment you must Officially present at least TWO possible improvements to your position and explain why you think this should be granted to you.

### **SECRETARY REPORT SITCH 4: PERSONAL REVIEW**

You must provide a full blown no hold-backs assessment of how fucking ghetto you were as a secretary this year. Look deep into your actions as Secretary and include an in depth analysis of the mistakes you made in your position and any damage you might have done to the club as a whole. If you think you ledged it, talk about your achievements but also talk about how you might have ledged it even more if you were more ledge. You should give yourself a rating of 1 - 10 and explain why you chose this rating.

### **SECRETARY REPORT SITCH 5: CANDIDATES FOR SUCCESSION (OPTIONAL)**

In your official duty as a Secretary of the Dog Club, you should always be on the lookout for possible successors to your position and potential sitches who may EVEN be better for this secretary position than you. In this section list any potential DOG CLUB members who you may think have what it takes to feel your shoes. Take this section seriously as it is being submitted to Department of Secretaries and may be used as the CRITICAL proof of appointment in the event of your death or expulsion.

### **SECRETARY REPORT SITCH 6: PLANS FOR THE FUTURE**

Finally, in this final segment of the OFFICIAL SECRETARY report outline your plan for the following year and beyond as SECRETARY of EXPULSION. Include in detail every action you are planning to take and as much as you can PROVIDE specific dates you hope to achieve goals. In this section, you should PROVIDE no LESS than 5 plans you have for the future.

*Note: A copy of this Secretary Report will be submitted to The Secretary of Judgment for official judgement. So be wary of just hooping this super ghetto style.*
